2. Important Dates and Information Related to the 88th Legislative Session

Mr. Cheng stated that bill filing started on Monday, November 14, 2022, and many bills have been filed already.

Mr. Cheng stated that the big news for the 2023 session is a 27-billion-dollar surplus which is good news for the state. Given the surplus, the Governor has asked different groups for their wish list in terms of what they need.

3. Update on bills relating to the Texas Board of Professional Engineers and Land Surveyors

Mr. Cheng stated that agency staff do a great job of tracking all the bills related to engineering and land surveying. Most of the bills tracked thus far relate to being a state agency. Nothing has been filed regarding regulating or changing anything with Engineers or Land Surveyors.

Dr. Kinney stated that in the exhibit provided he had provided the process of how we monitor the bills through Telicon which is a very common legislative tracking service. Dr. Kinney stated that staff reviews every single bill filed and flags those that may have anything even tangentially related to engineering, land surveying, or agency operations. Staff also flags bills that affect other agencies as they could expand to impact TBPELS.

Dr. Kinney stated that the last day to fill a new bill is March 10, 2023.

Ms. Friese asked to be kept abreast more routinely on bills affecting the agency. Dr. Kinney stated he would provide the Telicon report to members as often as they would like.

4. Legislative Communication Plan

Dr. Kinney stated that because bill filing just started and we have no real issues, the Communication Plan is only a short summary of agency operations and contact

information. It shows what is going on with our agency and we can take it and hand it off to legislative members that we meet with.
