Mr. Brackin addressed the board concerning his application for registration as an RPLS. Under current statute and rules he does not meet the qualifications for education and asks the board to reconsider his application and that he be allowed to take the Texas Specific Surveying Exam (TSSE).

This applicant applied for licensure as a PE. Mr. Dew appears before the Committee having multiple recent criminal convictions. The Committee and applicant discussed his experience and lessons learned from his convictions.

It was MOVED/SECONDED (Rubiano/Johnson) to recommend to the Board at its Regular Quarterly Board meeting on August 10, 2023, that Mr. Dew be issued a PE license after the successful completion of the 30-hour Basic level Engineering Ethics course from the Texas Tech Murdough Center. A vote was taken, and the MOTION PASSED.

McDonald, Mitchell Louis

This applicant applied for registration as an RPLS. Mr. McDonald appears before the Committee having multiple recent criminal convictions. The Committee and applicant discussed his experience and lessons learned.

It was MOVED/SECONDED (Rubiano/Johnson) to recommend to the Board at its Regular Quarterly Board meeting on August 10, 2023, that Mr. McDonald be allowed to sit for the TSSE upon the successful completion of the 30-hour Basic level Surveying Ethics course from the Texas Tech Murdough Center. A vote was taken, and the MOTION PASSED.

Mr. Sims stated that these items were discussed at the May Committee meeting. These amendments are reinstatements of previously adopted provisions that were inadvertently repealed and corrections of an erroneous rule citation. No public comments were received on the proposed amendments.

It was MOVED/SECONDED (Rubiano/McClinton-Stoglin) to recommend to the Board at its Regular Quarterly Board meeting on August 10, 2023, to adopt the rule amendments in agenda items #4-5 and post in the Texas Register. A vote was taken, and the MOTION PASSED.

Dr. Kinney stated that these rules relate to the changes that have been previously approved regarding surveying exams and the implementation of the PS and TSSE exams. No public comments were received on the rule amendments.

It was MOVED/SECONDED (McClinton-Stoglin/Johnson) to recommend to the Board at its Regular Quarterly Board meeting on August 10, 2023, to adopt the rule amendments to Chapter 134, Subchapter G – Examinations and post in the Texas Register. A vote was taken, and the MOTION PASSED.

Mr. Strong discussed the tests for land surveying. The TSSE exam is ready and fully developed, and the PS exam is currently available to Texas applicants via NCEES. The exhibit associated with this item included a list of TSSE exam dates. The next exam is set to take place in Austin, Texas, on October 13, 2023. There will be three more testing dates in the following year: March 22, June 23, and October 18, 2024. The agency website contains information about the exam dates as well as study guides, study reference information, and frequently asked questions.

The L.S.L.S. exam has historically been given on the same day as the RPLS exams. We are looking at separating the exam dates and using proctors to administer the exam at the Board office.

Mr. Strong reported there should be about 100 people present for the TSSE on October 13, 2023.

Mr. Strong reviewed the PE exam data and noted a continuous increase in the number of examinees and licensees.

Mr. Strong also mentioned that all NCEES exams are converted to computer based delivery except for the structural engineering exam.
