

TEXAS BOARD OF PROFESSIONAL ENGINEERS AND LAND SURVEYORS
November 9, 2023, Board Meeting Disciplinary & Administrative Actions

Hayden Homes, Dripping Springs, TX; Case Number B-41375

Violation: Hayden Homes used, caused to be used, affixed, or caused to be affixed or in any other manner, regardless of the means, attached or in any way depicted an engineering seal or a representation of an engineering seal without the express permission of the currently active licensee.

Act/Rule Violated: 22 Tex. Admin. Code §137.37(b).

Resolution: Cease and Desist Order and Administrative Penalty of \$250.

Paul Douglas Marinshaw, P.E. #49874, Alvin, TX; Case Number D-40597

Violation: Mr. Marinshaw did not exercise reasonable care to prevent the association of his name, professional identification, and seal in connection with any venture or enterprise which the engineer knew, or should have known, is engaging in trade, business, or professional practices of a fraudulent, deceitful, or dishonest nature, or any action which violates any provision of the Texas Engineering Practice Act or board rules and Mr. Marinshaw aided or abetted, directly or indirectly, an unlicensed person or business entity in the unlawful practice of engineering.

Act/Rule Violated: 22 Tex. Admin Code §§137.63(b)(3) and 137.63(c)(1).

Resolution: Two Year Probated Suspension contingent upon successful completion of the TTU Engineering Ethics Basic Course and remittance of an Administrative Penalty of \$3,538.

Correen Corena Robertson, P.E. #106494, Ft. Worth, TX; Case Number D-41876

Violation: Ms. Robertson issued statements in the practice of engineering that were misleading or tended to create a misleading impression and Ms. Robertson failed to act as faithful agent for their employers or clients.

Act/Rule Violated: 22 Tex. Admin Code §§137.57(a)(3) and 137.63(b)(4).

Resolution: One Year Probated Suspension contingent upon successful completion of the TTU Engineering Ethics Basic Course, restitution in the amount of the retainer she accepted, and remittance of an Administrative Penalty of \$2,500.

Matthew Stephen Monroe, P.E. #100692, Dallas, Worth, TX; Case Number D-42309

Violation: Mr. Monroe failed to exercise reasonable care to prevent the association of the engineer's name, professional identification, seal, firm or business name in connection with any venture or enterprise which the engineer knows, or should have known, is engaging in trade, business or professional practices of a fraudulent, deceitful, or dishonest nature, or any action which violates any provision of the Texas Engineering Practice Act or board rules and Mr. Monroe failed to act as faithful agent for their employers or clients.

Act/Rule Violated: 22 Tex. Admin Code §§137.63(b)(3) and 137.63(b)(4).

Resolution: Formal Reprimand and an Administrative Penalty of \$500.

Jordan Reeves Garrett, R.P.L.S. #6154, Blanco, TX; Case Number D-40753

Violation: Mr. Garrett failed to respond fully and truthfully to all Board inquiries and furnish all maps, plats, surveys or other information or documentation requested by the Board within 30 days of such registrant's, licensee's, SIT's or Firm's receipt of a Board inquiry or

request concerning matters under the jurisdiction of the Board and Mr. Garrett evaded his statutory responsibility or his responsibility to a client, employer, and the public. Also, Mr. Garrett performed any acts, allowed any omission, or made any assertions or representations which may be fraudulent, deceitful, or misleading, or which in any manner whatsoever, tended to create a misleading impression.

Act/Rule Violated: 22 Tex. Admin Code §§661.60(a), 663.3(3), and 663.10(7).

Resolution: Two Year Probated Suspension contingent upon remittance of an Administrative Penalty of \$3,100, remittance of restitution of \$1,250.00, and successful completion of 10 hours of surveying ethics.

Robert Lee Collett, Jr., P.E. #104929, San Antonio, TX; Case Number D-42288

Violation: Mr. Collett was convicted of a felony and sentenced to incarceration. Revocation of Mr. Collett's Texas professional engineer license occurred by operation of law on May 8, 2023, the date Mr. Collett was sentenced to incarceration.

Act/Rule Violated: 22 Tex. Admin. Code §139.43(a)(1), Texas Occupations Code, Ch. 53.

Resolution: Revocation of Texas professional engineer license by operation of law.
