# Professional Surveyor Criminal History Record Check Requirement

Fingerprinting for RPLS is now open and must be completed prior to December 31, 2020.

In meeting with legislatively mandated fingerprinting requirements for all professional license holders, all active RPLS and LSLS licensees must complete a one-time, criminal history record check (CHRC) prior to renewing their license this year.

After successfully completing the electronic fingerprint session at the state contracted vendor IdentoGO, TBPELS will receive a file daily with information regarding any matches to the DPS or FBI databases. If electronic fingerprinting is not possible, licensees may have their fingerprints processed by any law enforcement agency and then submitted to the state vendor for the record check requirement.

The only exceptions to this requirement are currently inactive RPLS or RPLS who are also Professional Engineers and have previously met this requirement as part of their PE renewals. Please note: An RPLS who is in inactive status and does not do a background check will have to complete the background check requirement prior to returning to inactive status. On October 9, 2020, TBPELS posted amendments to Chapters 138 and 139 to implement necessary changes as required by House Bill (HB) 1523, 86th Legislature, Regular Session (2019), related to the merger of operations of the Texas Board of Professional Engineers and the Texas Board of Professional Land Surveying into the Texas Board of Professional Engineers and Land Surveyors.
